3. Qualifications

General

The applicant for the post of the Chief Vigilance Officer shall fulfill the following conditions:

- a) Shall be a citizen of India;
- b) Must not have attained the age of 65 years as on 1st of March, 2023;
- c) Must be active and healthy;
- Must profess Hindu religious rites and has to be a believer of God and temple worship; and
- e) Must have such character and antecedents which would qualify him for service in the post.

Educational Qualification

The Applicant must possess a Bachelor's degree from any recognized University.

Essential

A person shall not be qualified for appointment unless the candidate has held the post of a Class-1 Officer or that of an

equivalent rank under the Central Government or the State Government, for at least 3 (three) years, and retired from service.
