1. The envelope containing the tender should be superscribed as "**Tender for the civil works to be carried out at Panchajanyam Guest House**" and should be addressed to the Executive Officer, Sree Padmanabha Swamy Temple, Fort P.O, Thiruvananthapuram.
2. The tenderer should have minimum 5 years of experience in Civil works. Proof of works done should be submitted along with the tender.
3. Each tender should be accompanied by an Earnest Money Deposit (EMD) of Rs.3500/- by way of Demand Draft and EMD drawn in favour of the Executive Officer, Sree Padmanabha Swamy Temple, Fort P.O, Thiruvananthapuram. Late and incomplete tenders and tender without EMD will not be accepted.
4. Withdrawal of tender after its acceptance or submitting tender not according to the specifications will entail cancellation of tender.
5. The tenderer should have done civil works for Rs. 5 Lakh or above.
6. The total rate/amount quoted should be inclusive of all taxes and duties including loading and unloading charges etc.
7. Tenders will be opened in the presence of tenders who may be present at that time.
8. If the date of opening the tender happens to be a holiday due to unexpected circumstances tender will be opened on the next working day at the same place.
9. The Executive Officer has the right to accept or reject any or all of the offers without assigning any reason. The decision of the undersigned in finalizing the tenders will be final and binding.

10. Payment as per the invoice shall be made only after the works carried out as per specifications and with respect to the completion certificate of a Technical Expert. Tenderer is liable to replace the defective items/rectify the defective items immediately on receipt of intimation.
