NOTICE INVITING TENDER

Sealed Tenders are invited for the supply and Installation of Bosch make PTZ camera 4 Nos (replace with new cameras in same location), Bosch make still camera 2 Nos(replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software(Bosch Video Management Software) required for Sree Padmanabha Swamy Temple.

Eligibility criteria, Technical Specifications, Terms and Conditions are discussed in the Document which will be supplied along with the tender forms. Tender forms can be had from the office of the temple up to 1:00 pm on 20.10.2023 on working hours on all working days. Interested Companies / Firms who are eligible as per the eligibility criteria can apply. Details are available in our website spst.in.

The Last date and time for submission of Tender along with EMD of Rs.15,000 (as DD. drawn in favour of Executive Officer) is 1:00 pm on 25.10.2023. All tenders received up to 3:00pm will be opened at 4:00pm on the same day.

1. Requirement:

Bids are invited under two bid system from the eligible vendors / distributers for supply, installation, Testing, Commissioning of Bosch make PTZ camera 4 Nos (replace with new cameras in same location), Bosch make still camera 2 Nos (replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software) required for the Sree Padmanabha Swamy Temple Security Office.

- 1. Interested parties may submit their tender in 2 separate sealed covers super scribed as
 - "TECHNICAL BID for CCTV" and "COMMERCIAL BID for CCTV".
 - a) Cover-I:— **Duly sealed cover** super scribed as "Technical Bid for CCTV For supply, installation, Testing, Commissioning of Bosch make PTZ camera 4 Nos(replace with new cameras in same location), Bosch make still camera 2 Nos(replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software)" **shall contain only technical bid** along with Basic Information, details of the company, covering letter for technical bid with all copies of certificates, work experience etc.
 - b) Cover-II: **Duly sealed cover** super scribed as "Commercial Bid For supply, installation, Testing, Commissioning of Bosch make PTZ camera 4 Nos(replace with new cameras in same location), Bosch make still camera 2 Nos(replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software)" **shall contain only Commercial Bid in the Temple's prescribed format**.
 - c) DD for Rs.15,000/- favouring EXECUTIVE OFFICER, Sree Padmanabha Swamy Temple as Earnest Money deposit drawn on any private or public sector bank
 - d) Both the sealed covers and DD shall then be put in one single envelope and sealed and duly super scribed "Application/Offer for supply, installation,



Testing, Commissioning of Bosch make PTZ camera 4 Nos(replace with new cameras in same location), Bosch make still camera 2 Nos(replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software)". This envelope should contain Technical and Commercial bids and DD of Rs.15,000 in favour of Executive Officer, Sree Padmanabha Swamy Temple" as Earnest money and is addressed to The Executive Officer Sree Padmanabha Swamy Temple.

- 2. Commercial Bid shall contain nothing but rate of equipment per item without any conditions.
- 3. "Technical Bid" will be opened first for short listing of parties/ firms for opening of "Commercial Bid".
- 4. Commercial Bids of only those parties will be opened who have qualified for short listing on opening of technical bid, will be opened.
- 5. The rate quoted should be inclusive of all incidental expenses at a uniform rate
- 6. All bidders are requested to study the details carefully before submitting their tenders.
- 7. Completed quotes in sealed envelopes should reach "The Executive Officer Sree Padmanabha Swamy Temple, Trivandrum on or before 3:00pm on 25.10.2023.
- 8. Rate quoted should be valid for a period of six months from date of order.
- 9. Tenders will be opened at 4:00pm at the Office of The Executive Officer, Sree Padmanabha Swamy Temple, Trivandrum on 25.10.2023.
- 10. The bid which is received after due date & time is liable for rejection. Applications incomplete in any respect & which are not legible are liable for rejection.
- 11. Each page of the bid should be signed. The application shall be signed by persons / persons on behalf of the organization having necessary authorization / Power of

Attorney to do so.

12. The Temple reserves the right to cancel one or all tenders without assigning any reason whatsoever.

2. Scope of the work:

- 1. The work consists of supply, installation, Testing, Commissioning of Bosch make PTZ camera 4 Nos(replace with new cameras in same location), Bosch make still camera 2 Nos(replace with new cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software) in accordance with the technical specifications, terms and conditions mentioned in tender documents.
- 2. The vendor has to supply and install the equipments in Sree Padmanabha Swamy Temple.
- 3. The specification of the equipment supplied should be equivalent or higher than the specifications mentioned in the tender document and the vendor should specify the brand/model/make in their technical offer.
- 4. After successful installation and testing, vendor has to impart the primary training to the staff of the office to operate the equipments.
- 5. The equipment supplied should be under on-site warranty for a period of 3 years. After completion of the warranty, the vendor has to provide 3 years comprehensive AMC at the agreed rates.
- 6. The prices quoted in the Commercial Bid should be inclusive of all materials, labour, tools and equipment freight cost of carriage, all taxes and duties, installation and commission, and necessary management for completion of the work.
- 7. The vendor shall quote the prices for providing complete solution. After placing the order, the Temple will not pay any extra amount which is not mentioned in the commercial bid.
- 8. All products/ items having certifications as specified in the technical specifications.
- 9. Intending tenderers can visit the site and make themselves thoroughly acquainted with the local site condition, nature and requirements of the works, facilities of transport condition, effective labour and materials, access and storage for materials and removal of debris and or wastes.
- 10. The vendor has to take care of cost of carriage, freight and other charges as also for any difficulties, including police restriction for

transport etc. for proper execution of work.

- 11. The successful vendor will not be entitled to any claim of compensation for difficulties faced or losses incurred on account of any site condition during the execution of work.
- 12. The Temple reserves the right to reject the lowest or any tender and also to discharge any or all of the tenders for each section or to split up and distribute any item of work to any specialist firm or firms, without assigning any reason.
- 13. The vendor should note that the tender is strictly on the item rate basis and their attention is drawn to the fact that the rates for each and every item should be correct, workable and self-supporting.
- 14. The AMC charges/year for each item after the warranty period also should be quoted in the financial bid. The AMC will not be measured for selecting the L1 price. The cost for the same may be paid after the expiry of warranty.
- 15. The applicant shall note that his tender shall remain open for consideration for a period of 60 (sixty) days from the date of opening of the tender.
- 16. The company should provide standby item in case the item is not repairable at temple and before taking away from the Temple for more than 48 hours.
- 17. Please note that the Temple will apply penalty as below in case of discrepancy in services
 - a. If the item is down for more than three working days, then Temple office will penalize Rs 200 / day and max for seven working days will be 1400/-.
 - b. If the item is down more than seven working days the Temple will revoke the Bank Guarantee.
- 18. The supplier should give Bank Guarantee for a value of 5% on contract value.

3. General Conditions:

- 1. The Successful Bidder will be engaged for supplying, installation, Testing, Commissioning of Bosch make PTZ camera 4 Nos (replace faulty cameras in same location), Bosch make still camera 2 Nos(replace faulty cameras in same location), Bosch make storage server 1 No which can be integrated with the existing CCTV System Software (Bosch Video Management Software) to Sree Padmanabha Temple.
- 2. There will be no escalation of rate after submission of the tender.
- 3. Payment Terms: Payment will be made against invoice in triplicate after completion of job & after getting of work completion report from the Deputy Commissioner of Police, Temple Security.
- 4. The Temple reserves the right for the following:
 - Reject any or all proposals received in response to the tender without giving any reason whatsoever
 - Reject the proposals received in response to the tender containing any deviation from the payment terms stipulated
 - To independently ascertain information from other institutions to which the company / firm has already executed the similar services for similar assignment.
 - Apply whatever evaluation criteria deemed appropriate for evaluation of Technical Bids.
 - To terminate the services if the assignment is not proceeding in accordance with the terms of contract or undue delay is taking place in execution of the assignment.

5. Signing of Contract / agreement

The successful bidder shall sign an agreement within 7 days from date of "acceptance of the tender" with the Temple in the prescribed form on a judicial stamp paper. All legal expenses, incidental thereto shall be borne by the bidder. If the bidder fails to sign the agreement within the stipulated time the Temple reserves the right to cancel the "Letter of acceptance" and forfeit the Earnest money deposit submitted by the bidder.

6. Permit and Licenses



Permissions from the competent authorities for transportation of the materials/equipment to execute the purchase/work orders are the responsibility of the vendor.

The software/computer programs used to execute the purchase/work orders should be licensed from the respective vendor/manufacture/supplier.

7. Taxes and Duties

The vendor must include in their tender prices quoted all duties, royalties, cess, GST or any other taxes or local charges if applicable. No extra claim on this account will in any case be entertained.

8. Earnest Money and Retention money

The bidder will have to deposit an amount Rs.15,000/- in the Tender Notice in the form of Bank Draft drawn in favour of "The Executive Officer, Sree Padmanbha Swamy Temple" at the time of submission of tender as Earnest Money. No interest will be paid on the Earnest money. The Earnest money of the unsuccessful bidders will be refunded without any interest soon after the decision to award the work is taken or after the expiry of the validity period of the tender.

The retention amount of 5% of the work value will be kept for 39 months from the date of completion of the work and the retention amount will be refunded to the bidder, after deducting any sum due from the bidder on any account under this contract, 30 (thirty) days after the end of defects liability period provided the bidder has satisfactorily carried out all the work and attended to all defects in accordance with the conditions of the contract. No interest is allowed on retention money.

9. Liquidated Damages

If the Bidder fails to complete the works within the time for completion stated in the tender document or elsewhere or within any extended time under allowed by the Temple, the Bidder shall pay the Temple a sum at the rate of 1% (one per cent) of the Contract Value per week of delay subject to a limit of 10% (ten percent) of the Contract Value as "Liquidated damages" for the period during which the said works shall so remain incomplete and the Temple may deduct aforesaid sum towards such damages from any monies due to the Bidder.

10. Support of the manufacturers (OEMs):

The bidder shall furnish MAF of the equipment manufacturers against the items used in the works, with a commitment to direct support for the maintenance, supply of the spares and up-gradations by the OEM.

4. Eligibility Criteria for the bidder:

1.	Bidder should have a minimum of 5 years experience in commissioning of Server Systems at Nationalized Banks/Govt. Sectors/Temples by agencies having authorized dealership/OEM's. The bidder should enclose manufacturer's authorization firm certificate from the Original Equipment Manufacturer (OEM's) for the items
2.	The bidder should give Bank Guarantee for a value of 5% on contract value
3.	Proof of registration with GST, and recent copies of the payment remittance proof should be submitted.
4.	The bidder/OEM should be having office and service centre in Trivandrum. The company should have service network after sales within a radius of 10 kms from Temple. Proof of the same should be submitted.
5.	The validity of the quote should be 90 days
6.	The company should not be black listed by any PSU banks/Govt. organizations. Self declaration should be submitted by the authorized official of the company.
