- 1. The envelope containing the tender should be super scribed as "Tender for the Maintenance and repair works at Conference hall" and should be addressed to the Executive Officer, Sree Padmanabha Swamy Temple, Fort P.O, Thiruvananthapuram.
- 2. The tenderer shall be of Hindu religion.
- 3. The quality of the materials used shall be of the first grade.
- 4. The tenderer should have minimum 5 years of experience in similar works. List and proof of similar works undertaken by the Agency/Contractor should be submitted along with the tender.
- 5. Each tender should be accompanied by an Earnest Money Deposit (EMD) of Rs.2,200/- by way of Demand Draft drawn in favour of the Executive Officer, Sree Padmanabha Swamy Temple, Fort P.O, Thiruvananthapuram. Late and incomplete tenders and tenders without EMD will not be accepted.
- 6. Withdrawal of tender after its acceptance or submitting tender not according to the specifications will entail cancellation of tender.

- 7. The tenderer should have done similar works for Rs. 10,00,000/- or above.
- 8. The total rate/amount quoted should be inclusive of all taxes and duties including loading and unloading charges etc.
- 9. Tenders will be opened in the presence of tenderers who may be present at that time.
- 10. If the date of opening the tender happens to be a holiday due to unexpected circumstances, tender will be opened on the next working day at the same place at the same time.
- 11. The Executive Officer has the right to accept or reject any or all of the offers without assigning any reason. The decision of the undersigned in finalizing the tenders will be final and binding.
- 12. On receipt of work order, the Agency/Contractor should complete the work within 45 days and work bill/invoice should be submitted for effecting payment.
- 13. The Payment will be effected only after satisfactory completion of work as per specifications and on receipt of the completion certificate of the Technical Expert of the Temple. No advance or part payment shall be given to the Agency / contractor
- 14. Tenderer is liable to replace the defective items/rectify the defective items used in this work immediately on receipt of intimation from the Temple.
- 15. The tenderer is allowed to ispect the site if he sodesire, prior to submitting of tender. For this inspection he will have to inform in advance and carryout the site inspection on any temple office working day during working hours.
