Each tender should be accompanied by an Earnest Money Deposit (EMD) of Rs.18,000/- (Rupees Eighteen Thousand only) by way of Demand Draft drawn in favor of the 'Executive Officer, Sree Padmanabha Swamy Temple, Fort P.O., Thiruvananthapuram' or remit the amount at Temple counter and submit the receipt. Late and incomplete tenders and tenders without EMD will not be accepted.

5. Sealed quotations should reach the Temple Office on or before 11.00am on 18.08.2025 in a sealed envelope and should be deposited in the tender box kept in the Temple office situated at Ulsavamadam buildings at North Nada.

- 6. The sealed quotations will be opened at 11.30am on 18.08.2025 itself, at the office of the Executive Officer in the presence of bidders who are present at that time.
- 7. Withdrawal of tender after its acceptance or submitting tender not according to the specifications will entail cancellation of tender.
- 8. If the date of opening the tender happens to be a holiday due to unexpected circumstances, tender will be opened on the next working day at the same place at the same time.
- 9. The Executive Officer has the right to accept or reject any or all of the offers without assigning any reason. The decision of the undersigned in finalizing the tenders will be final and binding.
- 10. The payment will be effected only after satisfactory installation and performance of the CCTV system as per specifications and on receipt of work completion certificate from the System Officer, Sree Padmanabha Swamy Temple. No advance or part payment shall be given.
- 11. During warranty period service/installation should be at free of cost.
- 12.If any more details are required in this regard, it can be obtained directly from the Temple Office, at the North Nada.
- 13. The tenderer and workers should strictly belong to Hindu religion (who enter the Temple for works) and shall follow Temple customs.
